1. Certified copy of Identity document of applicant
2. One copy each of all municipal accounts i.e. water, electricity, rates (not older than 3 months)
3. The endorsed Title Deed of the property

QUALIFYING CRITERIA

1. The applicant must be sixty (60) years or older
2. The applicant must produce a certified copy of his / her South African bar coded Identity Document
3. The Scheme must be registered in terms of the Housing Development Scheme for Retired Persons Act 65 of 1988
4. The Scheme must be registered with and regulated by the South African Association for Homes for the Aged (SAHA)
5. The Title Deeds of the property must be appropriately endorsed
6. The applicant must be the registered owner of the primary property. This includes co-owners who are married to each other or property owned solely by either spouse
7. In the case of joint ownership, all owners must meet the qualifying criteria
8. The applicant must reside permanently on property
9. The value of the primary property must not exceed a value as determined by a Council resolution at its annual budget
10. In the case of a Trust, the Trustee must meet all of the above criteria. A copy of the Title Deed must be produced
11. Executors / Administrators of deceased estates, Liquidators and Trustees are excluded from the rebates.
